Shelter Intake Hub: The organization launched a new homeless shelter intake hub that helped more than 700 individuals find shelter. It provides a centralized, 24/7 hotline and intake process to connect people with emergency resources. Family Services: As of the end of 2024, Family Promise of Pierce County had helped house 145 families. Of these, 23 had already secured stable housing within the first 13 weeks of the year. Rapid Rehousing: The organization helped 145 families move into stable housing since the beginning of the year. The average time a family spent in emergency shelter was 26 days. A significant number of these families (141) were able to find and pay for housing without subsidized housing vouchers.
